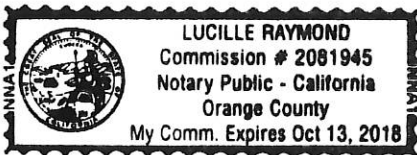

REJECTION OF BIDS
