

days set forth, Contractor shall forfeit and pay to the County the sum of \$500.00 per day for each calendar day the work remains incomplete, to be deducted from any payments due or to become due to the Contractor. (Reference General Conditions and Special Conditions)

REJECTION OF BIDS

The undersigned agrees that the County reserves the right to reject any or all bids, and reserves the right to waive informalities in a bid or bids, not affected by law, if to do so seems to best serve the public interest.

VALIDITY OF BIDS

The undersigned agrees that this bid will remain valid for sixty (60) days after the scheduled bid opening.

STATE LICENSES

The undersigned hereby certifies that he is currently the holder of a valid class "B" license as a contractor in the State of California and that the license is the correct class of license for the work described in the project drawings and specifications. INSURANCE

1. Sheet M1.2 - The design that is shown in drawing M-1.2 is not a typical shooting range verification system. It not only has 2 MAUs but also 2 Exhausts which is very rare for a range that is only 31' wide and both units overlap each other for double supply and double exhaust.. Also the evaporative cooling units seem to be very small for the size and airflow needed for this size of range. Many of the specifications for this shooting range mechanical system seem to be for a system with air conditioning and recirculation not an evaporative cooled purge style system shown in the drawings.

RESPONSE: Provide mechanical system as specified.

Spec Section 23 01 00 - 2.02B - Exhaust Mid filters - are exhaust mid filters required on this project? It is
only typical to have these mid filters in a recirculation system, not a purge system as shown in the
drawings.

RESPONSE: Yes. Provide Exhaust Mid-Filters per paragraph 2.02.B

3. Spec Section 23 01 00 - 2.03A.5 - All ductwork outside of the building shall have R-8 insulation - Again this his usually only found in a system with recirculation. The purge system as shown in the drawings will not benefit at all from having insulated exhaust ducting. Please advise if this is required.


