In compliance with your invitation for bids, the undersigned has carefully examined the project Bid Documents, including the drawings and specifications, for the scope of work which is to provide and install a masonry structure in conjunction with a retaining wall, a 120' antenna pole, an electrical distribution panel, an automatic transfer switch and a backup generator at the site behind the existing fire station as indicated in the bid documents in Forest Falls California, and fully understands the scope and meaning of the Bid Documents.

The undersigned hereby agrees to furnish all materials, labor, tools, equipment, apparatus, facilities, and transportation necessary to complete all work in strict conformity with the drawings and specifications, and to execute the contract to the satisfaction of the Real Estate Services Department – Project Management Division, at the following cost(s):
